The City and Borough of Juneau, Alaska:

We have audited, in accordance with auditing standards generally accepted in the United States of America, the financial statements of the governmental activities, the business-type activities, the discretely presented component unit, each major fund, and the aggregate remaining fund information of the City and Borough of Juneau, Alaska (City and Borough) as of and for the year ended June 30, 2008, and issued our report thereon dated December 18, 2008. We have also audited the accompanying Schedule of Passenger Facility Charges of the City and Borough for the year ended June 30, 2008. This schedule is the responsibility of the City and Borough. Our responsibility is to express an opinion on this schedule based on our audit.
